Sub: Clarification- : Regarding Operational and rationalisation of bed capacities of CCC Level-I

In continuation of the letter no. MD/NHM/Pb/2020/Spl.1/3396 (R) – 3398 (R) dated 22.05.2020, and as per meeting held on 21-5-2020 with Medical Emergency Management Committee (MEMC) under the chairmanship of ACS (H), this is clarified that

1. The out of total mapped bed capacity of the Priority 1 CCCs of the below mentioned districts along with linkage to minor/small districts, minimum beds are to be operationalized (with the revised HR norms and honorarium) is as

Fazilka	50	Ferozepur and Fazilka

Gian Sagar 350 beds CCC+ Level II (200 + 150)	200	Ropar, Fatehgarh Sahib, Mohali
Chintpurni Medical College CCC+ Level II (400+ 100)	400	Gurdaspur, Pathankot, (Dasuya, Mukarian parts of Hoshiarpur)
Medical College Patiala CCC+ Level II (150+ 100)	150	Patiala

This is also clarified that the District Administration can increase the number of beds to operationalise as per need or demand of the hour on further influx of patients in their districts

2. HCW is to be engaged as per the proportionate need of the situation.

3. HR placement, Quarantine, Hotel stay norms, and the revised honorarium for the increased HCW, are to be followed as communicated earlier in the letter no MD/NHM/Pb/2020/Spl.1/3396 (R) – 3398 (R) dated 22.05.2020,
