Regarding quarantine facilities for residents of Punjab returning from outside the state.

As you are aware that residents of Punjab who could not return back to their native places in Punjab due to lockdown are now returning back to the State from Maharashtra, Rajasthan, and other places. The Government of India is contemplating allowing residents of Punjab stranded in other States of India to return back shortly. The flow of such people is likely to increase in the near future. As per guidelines of Department of Health & Family Welfare all these people are required to be quarantined and tested for COVID-19 infection.

It is learnt that most of the districts have created 'Dedicated Quarantine Facilities' in the districts to house these people. It is clarified that in case the 'Dedicated Quarantine Facilities' fall short for the persons to be quarantined then in that case the District Administration may use 50% of the capacities of the CCCs identified by them for the purpose of quarantine of these people. All appropriate arrangements may kindly be made.

Symptomatic persons may be continued to be taken to the District COVID Health Center/Isolation Facilities Phase I as per the current practice. All cases testing positive should be provided medical care as per assessment of medical officers. However, all persons testing negative may be sent to their residences for home quarantine for 14/21 days. Strict enforcement of home quarantine must be ensured by the Deputy Commissioners with proper surveillance and supervision as per instructions issued earlier.
