Subject : COVID-19 : Purchase and installation of laundry machines for washing of clothes of the COVID-19 patients and hospital gowns.

It has been informed by the Civil Surgeons/Medical Superintendents and the concerned SMOs that the laundry tie-up for the hospital linen is already in place in all the Isolation Centres. It has also been verified and certified by the SMOs concerned that the linen is being washed as per protocol after dipping it in 1% hypochlorite solution for 30 minutes. For hospital gowns which are worn by the patients and the personal clothes of the patients different arrangements have been made.

2. It has now been decided that for every 25-30 beds in the Isolation Facility one automatic washing machine with dryer with a capacity of 7-9 kgs should be got installed in the washrooms or wherever adequate space is available in the Isolation Facility. These machines should be used for washing hospital gowns and clothes of COVID-19 patients only.

3. The Civil Surgeons/Medical Superintendents should purchase these machines locally in accordance with the capacity in the Isolation Facility in the district and must ensure that these machines are operational within next two days.

4. Any help that would be required from the District Administration for procurement of these machines locally must be sought. It is again emphasized that the machines should be properly fitted in consultation with the SMOs of the Isolation Centres at an adequate place with proper water & electricity supply and enough space for movement etc.

5. Stands for drying the clothes must also be purchased as per requirement in the Isolation Facility locally and a space where the clothes will be kept to dry should be earmarked.

6. The State Disaster Response Fund will be a valid charge for this purpose.

7. Details of the machines bought and installed alongwith specifications and the price of the machine and the number of stands bought should be conveyed to MD/PHSC immediately after installation.
